#### **BOARD OF SUPERVISORS QUESTIONS AND COMMENTS**

Board Members expressed their concern regarding the City of Tracy submitting a proposal for the VA Clinic. County Counsel Terrence Dermody stated that if the Board wished to discuss this matter, a motion should be considered to add it to the agenda. Chairman Gutierrez said that the matter would be on an agenda at a later date.

Supervisor Sieglock stated that the Veterans Service Officer could provide Board Members information in a memorandum.

Supervisor Sieglock expressed his concern about Pardee, Camanche and New Melones Dams and flooding downstream. He said that maybe it is time to replace Pardee Dam as it is an old structure. Supervisor Sieglock suggested at this point Public Works and the County Administrator staff should gather information regarding these concerns.

Supervisor Ornellas said that he is seeing trash dumped all over the county. Supervisor Sieglock recommended that the Sheriff-Coroner report to the Board on this matter.
