- 1. Company name and mailing address.
- 2. Contact name, phone number and email address.
- 3. The class of the Contractor's License(s) held, Contractor License Number(s), and Contractor License expiration date.
- 4. The type(s) of work contractor is licensed to perform (i.e., Class A, B, C, etc.).

This announcement will be sent to various trade journals for publication as a requirement of the CUPCCAA to establish and maintain a list of qualified contractors per the applicable sections of the Public Contract Code. This Invitation is subject to any and all applicable laws, regulations and standards.

Email notification will be returned by the County validating/invalidating registration and providing Vendor ID number. If registration is invalidated, an explanation and/or request for additional information will be included in the notification.
